Community Working Groups

The Community Working Groups (CWGs) remain an important platform to engage with local stakeholders and address concerns following the incident on 7 April.

The CWGs are being implemented by independent facilitators WSP, who have established the working parameters and membership to the groups is now closed. Information and discussion from the recent CWGs included:

- Remediation, operation and monitoring (next meeting Tuesday 6 September, 6:30pm)
 Addressing previously raised questions and providing information on Kurnell Terminal operations.
- Community & Brand Kurnell (next meeting Wednesday 7 September, 6:30pm)
 Identifying opportunities for community investment and projects to enhance amenity in Kurnell.
- Emergency Management (next meeting Tuesday 13 September, 6:30pm)
 Understanding the roles and responsibilities of Ampol and emergency services, along with discussing the implementation of a dedicated communication tool to enable Ampol to directly notify residents of an emergency incident at the Kurnell Terminal.

Weather Monitoring

Ampol continues to closely monitor weather forecasts and patterns to identify systems that may converge on the Kurnell Terminal.

When required, Ampol will stand up a designated team of operational specialists, Kurnell Terminal management and liaise closely with emergency services. The response will also include communicating to the community and local stakeholders to ensure they are well informed.

The increased level of preparedness reinforces our ongoing commitment to operational excellence and being engaged stakeholder of the Kurnell community.

Wharf Drain Monitoring Program

The EPA and Ampol have agreed on a Pollution Reduction Program (PRP) as a response to observed odours at the stormwater drain at the Ampol wharf.

The PRP requires a period of routine monitoring of water being discharged from the stormwater drain to identify if any remnants of fuel related products from the Ampol premises are entering, and ultimately being released from the drain.

The monitoring program developed by Ampol / WSP and reviewed by the EPA to address the requirements of the RPR, which will soon be made available on the Ampol website.
