<b>Competition Period</b>	12.00am (AEST) on 01/10/2025 to midnight (AEDT) on 04/11/2025.
<b>Who can enter?</b>	Entry is only open to Australian residents aged 18 years or over.
<b>Who can't enter?</b>	Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
<b>Where will the competition run?</b>	All states and territories within Australia.
