Subject: Kurnell Port and Berthing Project SSD_5353 – Dredge and Spoil Disposal Management Plan (condition C36(a))

I refer to your email correspondence of 11 September 2013 and the submission of a Dredge and Spoil Disposal Management Plan (DSDMP), prepared pursuant to condition C36(a) and subsequently revised as a result of the Department's comments. A revised Plan (dated 17 September 2013) was provided via email dated 1 October 2013.

The Department has reviewed the revised Dredge and Spoil Disposal Management Plan and considers that it generally addresses the requirements of condition C36(a). The Director-General grants approval of the plan subject to the following:

- inclusion of contact details for the Gatehouse for notification of all oil spills and sheens (refer Section 3.1 and Emergency Contact List);
- inclusion in Section 6.3 of Emergency Response Management Plan to requirement of Condition C6 that the dredger and dredger tugboat should reduce speed to four (4) knots if a marine mammal is located within 420 metres of dredging; and
- completion of the Emergency Contact List.

It is noted that the DSDMP is required to be prepared and implemented as part of the Construction Environmental Management Plan (CEMP) required by Condition C35. The Department is in receipt of a revised version of that document for review, but that nothing in this approval should be taken as granting approval to the CEMP.
