We are excited to share some important progress from the Heart Start Kurnell initiative.

Two public access defibrillators have now been installed at the **Kurnell Post Office** and the **Whale Watching Platform** at **Kamay Botany Bay National Park**.

These life-saving devices are readily available and are a vital step in improving emergency response in our community,

In addition, the first community CPR course was recently held at the Kurnell Stingrays Clubhouse, and it was inspiring to see locals stepping up to learn these critical skills. If you would like to register your interest to attend a future CPR course, simply scan the QR code.

Kurnell Energy and Industry Hub drop-in session

Thank you to everyone who attended our recent drop-in session held at Marton Community Hall on 7 May. The session provided a valuable opportunity for residents to learn more about the potential Hub, featuring:

- A **terminal precinct** for ongoing fuel storage.
- An **energy precinct** including a possible Kurnell Battery Energy Storage System (BESS).
- An **industry precinct** to support logistics, manufacturing and stimulate local jobs.
- A **protected ecological area** to preserve local biodiversity.
- **Community investment** through a Voluntary Planning Agreement.

Stormwater

Ampol recently participated in a constructive meeting with Simon Kennedy MP and members of the community to discuss the condition of the local stormwater system.

The meeting provided a valuable opportunity for local stakeholders to come together and collectively discuss the impact of water accumulation in the Marton Park wetlands. This issue has been impacting nearby residents and limiting the use of public spaces.

As a long-standing member of the local community, we remain dedicated to working collaboratively with all stakeholders and support efforts to enhance the health and functionality of the stormwater system.

Quibray Bay mangroves

In 2024 a team of independent mangrove ecologists and marine scientists assessed mangroves in an area of Quibray Bay showing signs of defoliation (leaf loss).

The assessment concluded that hydrocarbons from the April 2022 oily water overflow were not considered to be the cause of the mangrove defoliation. Instead, there were several lines of evidence indicating the mangrove defoliation may be due to significant and ongoing freshwater conditions. While mangroves can tolerate freshwater, they cannot survive persistent inundation of freshwater.

Mangrove dieback is not unique to Quibray Bay, and it has been reported in other places in NSW, expected to also be due to very wet climatic conditions.

The results of the detailed assessment were submitted to the NSW EPA in May 2024. The NSW EPA have now completed their detailed review of the report and consider Ampol have met the requirements of the assessment.

Despite the findings showing the 2022 oily water overflow was not the cause of the defoliation, Ampol are planning to undertake some further voluntary assessment of the mangroves. Ampol's independent environmental specialists are currently planning the further assessment works and will continue to keep the EPA informed.

Terminal siren

Our siren is tested everyday at 12noon with a 1 x 10 second blast, and 2 x 10 second blasts on Mondays.

The siren is for on-site personnel only and people in the community do not need to take action.

In the event of a major incident that has potential to impact the community, Ampol will provide initial alerts and information via its community notification platform. Residents are advised to always follow any direction from emergency services.
